**On amendments to order №466 of the Minister of Energy of the Republic of Kazakhstan of December 21, 2017 "On approval of the Rules for organizing and conducting auctions, including qualification requirements for auction participants, content and procedure for submission of the application, types of financial support for the application for participation in the auction and conditions for their filing and return, the procedure for summing up and determining winners"**

**I order**

1. To add the following addition to Order of the Minister of Energy of the Republic of Kazakhstan №466 of December 21, 2017 "On approval of the Rules of organization and conduct of auctions, including the qualification requirements for auction participants, the content and procedure for submitting an application, types of financial support for participation in the auction and conditions for their submission and return, the procedure for summing up and determining the winners" (registered in the Register of State Registration of Normative Legal Acts №16240):

Rules for organizing and holding auctions, including qualification requirements for auction participants, content and procedure for submitting an application, types of financial support for an application for participation in the auction and conditions for their submission and return, the procedure for summing up and determining the winners, approved by the said order:

add paragraph 8-1 to read as follows:

«8-1. Auction trades for the selection of projects for the construction of solar and wind power plants are held in accordance with the information on the possibility of connecting to points of electric networks and reserved land plots for the planned construction of the objects specified in the Schedule.

At the same time, the documents provided for in subparagraphs 7) - 9) of paragraph 19 of these Rules shall not be provided for participation in the auction trade.

2. The Department of Renewable Energy of the Ministry of Energy of the Republic of Kazakhstan shall ensure in accordance with the procedure established by the legislation of the Republic of Kazakhstan:

- 1) state registration of this order with the Ministry of Justice of the Republic of Kazakhstan;
- 2) placement of this order on the Internet resource of the Ministry of Energy of the Republic of Kazakhstan;
- 3) within ten working days after the state registration of this order with the Ministry of Justice of the Republic of Kazakhstan, submission to the Department of Legal Service of the Ministry of Energy of the Republic of Kazakhstan of information on the implementation of the measures provided for subparagraphs 1) and 2) of this paragraph.

3. The supervising Vice-Minister of Energy of the Republic of Kazakhstan shall be entrusted with control over the implementation of this order.

4. This order shall enter into force sixty calendar days after the day of its first official publication.
