On amendments to the Order of the Minister of Energy of the Republic of Kazakhstan dated February 20, 2024 No. 73 «On approval of the auction schedule for the construction of newly commissioned generation plants with maneuverable generation mode for 2024»

In accordance with paragraph 3 of Article 65 of the Law of the Republic of Kazakhstan «On Legal Acts» and with paragraph 5 of the Rules for Organizing and conducting auctions for the construction of newly commissioned generation plants with a maneuverable generation mode, approved by Order No.161 of the Acting Minister of Energy of the Republic of Kazakhstan dated April 30, 2021 (registered in the Register of State Registration of Normative Legal Acts No. 22727), **I ORDER:**

1. To make the following change to the Order of the Minister of Energy of the Republic of Kazakhstan dated February 20, 2024 No. 73 «On approval of the auction schedule for the construction of newly commissioned generation plants with a maneuverable generation mode for 2024»:

the schedule of auctions for the construction of newly commissioned generation plants with a maneuverable generation mode for 2024, approved by the said order, should be set out in a new version in accordance with the annex to this order.

2. The Department of Electric Power Industry Development of the Ministry of Energy of the Republic of Kazakhstan should ensure that this order is posted on the Internet resource of the Ministry of Energy of the Republic of Kazakhstan no later than 3 (three) working days from the date of its signing.

3. To assign control over the execution of this order to the supervising Vice-Minister of Energy of the Republic of Kazakhstan.

4. This order comes into force from the date of its signing.
